

Better Vanity Limited Warranty

The warranty obligations of Better Vanity Inc. ("Better Bath") for this product are limited to the terms set forth below:

What is Covered

All our products come with a one-year warranty. Should the product contain manufacturer defects or if it does not work upon arrival, this warranty covers a max of two replacements within one year from the date you received your order. We will only honor warranty claims of purchases made from Better Vanity Inc or authorized dealers. After two replacements are issued, you have the option to opt for store credit. Proof of purchase is required.

Our limited warranty covers the shipping damage reported in 5 business days after delivery with our own carriers (shipping cost bill to us).

What is Not Covered

This limited warranty does not cover process defects, do not include the customer's subjective requirements for the product, and do not include small errors that do not affect the normal use and appearance of the product.

This warranty does not cover physical damage from misuse or accidental damage to the product.

This limited warranty does not cover a slight color difference between the real object and the picture. Due to lighting reasons, the color of the physical item will be different in different lighting environments, and it will also be slightly different when taken with a mobile phone or camera. Especially the specular and wood grain colors. For the color of the wood grain, please mainly refer to the grain of the wood grain to judge.

This limited warranty does not cover any shipping damage, loss in transit, or any mis-shipped items reported after 48 hours to as max as 30 days (upon to the dealer's policy) for authorized dealers. Any damage, deterioration, or malfunction resulting from any alteration, modification, improper or unreasonable use or maintenance, misuse, abuse, accident, neglect, exposure to excess moisture, fire, improper packing, and shipping (such claims must be presented to the carrier), or other acts of nature. This limited warranty does

not cover any damage, deterioration or malfunction resulting from the installation or removal of this product from any installation, any unauthorized tampering with this product, any repairs attempted by anyone unauthorized by Better Bath Vanity Inc. to make such repairs, or any other cause which does not relate directly to a defect in materials and/or workmanship of this product. How Long this Coverage Lasts

The standard limited warranty for Better Bath products is 1 year from the date of original purchase, no exceptions.

Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

What Better Bath Will Do

Better Bath will, at its sole discretion, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty: 1. Elect to repair or facilitate the repair of any defective parts within a reasonable period of time, free of any charge for the necessary parts and labor to complete the repair and restore this product to its proper operating condition. Better Bath will also pay the shipping costs necessary to return this product once the repair is complete. 2. Replace this product with a direct replacement or with a similar product deemed by Better Bath to perform substantially the same function as the original product. 3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.

What Better Bath Will Not Do Under This Limited Warranty

If this product is returned to Better Bath or the authorized dealer from which it was purchased, or any other party authorized to repair Better Bath products, this product must be insured during shipment, with the insurance and shipping charges prepaid by you. If this product is returned uninsured, you assume all risks of loss or damage during shipment. Better Bath will not be responsible for any costs related to the removal or re-installation of this product from or into any installation. Better Bath will not be responsible for any costs related to any setting up this product, any adjustment of this product, or any kind of costs required for a specific installation of this product.

How to Obtain a Remedy Under This Limited Warranty

To obtain a remedy under this limited warranty, you must contact either the authorized Better Bath reseller from whom you purchased this product or the Better Bath office nearest you. If it is decided that this product should be returned directly to Better Bath, this product should be properly packed, in the original carton, for shipping. Cartons not bearing a return authorization number will be refused and a refund will not be processed.
